礼品：

被委托为“主动馈赠的礼品”的物品是可接受的，并允许免除任何关税或增值税，只要提供的货物价值低于 45 欧元，由个人发给个人，并被单独包装。烟草制品、酒精饮料或香水/花露水的增值税或消费税没有减免。但是，在上述货物的总价值限额为 45 欧元的情况下，即使货物超过了上述限额，货物也将免除关税。

ii.25 支雪茄（每支雪茄的最大重量为 3 克）或

iii.10 支雪茄或

iv.50 克烟

b.酒精和酒精饮料

i.1 升蒸馏酒和烈性酒，酒精强度超过 22%（例如威士忌、白兰地、杜松子酒、朗姆酒、伏特加酒）或 1 升蒸馏酒和烈酒，开胃酒或酒基、塔菲、清酒或类似饮料，酒精强度不超过 22%，起泡酒或强化葡萄酒（如香槟酒，波特，雪利酒）

ii.2 升蒸馏酒

c.香水和花露水

i. 50 克香水或

ii. 0.25 升或 8 盎司的花露水

Gifts

Articles consigned as "Unsolicited gifts" are acceptable and will be allowed entry free of any duty or VAT providing the shipment is valued at less than 45 EURO, originated from and consigned to an individual, and are individually wrapped. There is no relief from VAT or Excise duty for tobacco products, alcoholic beverages or perfumes/toilet waters. However, subject to the overall value limit of 45 Euro per consignment mentioned above, relief from customs duty will be allowed on those goods up to the following limits even where goods in excess of those limits are contained in the consignment:

a. Tobacco products

- i. 50 cigarettes or
- ii. 25 cigarillos (cigars of a max weight of 3 grams each) or
- iii. 10 cigars or
- iv. 50 grams of smoking tobacco

b. Alcohol and alcoholic beverages

- i. 1 liter of distilled beverages and spirits, of an alcoholic strength exceeding 22% vol. (e.g. Whiskey, brandy, gin, rum, vodka} or 1 liter of distilled beverages and spirits

and aperitifs with a wine or alcohol base, tafia, sake or similar beverages of an alcoholic strength not exceeding 22% vol., sparkling or fortified wines (e.g. Champagne, port, sherry)

- ii. 2 liters of still wine
- c. Perfumes and toilet waters:
- i. 50 grams of perfumes or
 - ii. 0.25 liters or 8 ounces of toilet waters

Prohibited Items
