违禁物品：

除被视为不可邮寄的物品外，禁止下列物品：

Italy

Gifts

Casual donations sent by people abroad to friends in Italy, or imported personally by persons who are not residents of Italy, as gift for friends are not subject to duty or taxes. Articles consigned as "Unsolicited gifts" are acceptable and will be allowed entry free of any duty or VAT providing the shipment is valued at less than 45 EURO, originated from and consigned to an individual, and are individually wrapped.

Prohibited Items

In addition to items considered non-mailable matter, the following are prohibited:

- all forms of fibers

- all weapons/arms whether they are intended for sport, hunting, combat or collectors' items
- Atlantic red tuna (*Tumnus Thymus*) originating from Belize, Panama, or Honduras
- certain U.S. Beef hormones
- albuminoidal substances; modified starches, enzymes
- antiques
- airline tickets, blank stock
- asbestos
- bearer share certificates; bonds, cheques, open tickets
- edible fruit/nuts, peel of citrus fruit or melons
- eggs and dairy produce
- fish and other aquatic invertebrates
- furs
- fossilized animals
- fertilisers
- honey
- hunting trophies
- insects
- items having a flexible metal blade entirely contained in a plastic, paper, or fabric sheath
- L-tryptophan and any items having L-tryptophan as an ingredient
- lithium batteries or cell, in or outside of equipment
- meat and edible meat substances
- medical thermometers containing mercury intended for human use
- mineral products and fuels
- prepared foodstuffs;
- products of chemical industries

- precious metals and stones
- ores, slag and ash
- rubber erasers that are similar in appearance to food products that are easily ingested
- tobacco and tobacco substitutes
- toys and games containing copper sulfate
- live animals, animal products
- vegetable products
- sugar and sugar confectionery
- soap, organic surface agents
- works of arts, pieces and antiques
- food products, vitamin and mineral supplements and medicines
- alcoholic beverages, spirits
- animal and animal products
